16 – 30 people\$55.00

3 hour maximum * Must hire 1 extra life guard

31 – 45 people.....\$80.00

3 hour maximum * Must hire 2 extra life guards

46+ or more people\$100.00

3 hour maximum * Must hire 3 extra life guards

Parties during pool hours of 31 or more may start no earlier than 6:00 p.m.

After Pool Hours

After hour pool parties may start an hour before closing.

Rental Fee

1-20 people\$55.00

21-50\$80.00

51-100\$100.00

Lifeguards Required

1-15 people = 1 guard

16-30 = 2 guards

31-45 = 3 guards

46+ = 4 or more

3. **By signing this Rental Agreement Form, you have waived MSRC and all its members of all liability associated with the rental of this pool.**
4. **All areas (pool deck, bathrooms, grill and pool) must be cleaned and lights turned off before leaving. Check duty list in the office.**
5. **All gates must be secured at the end of your event.**
6. **Your Security Deposit will be refunded to you when the pool has been checked the following day.**
7. **In the event damages do occur that exceed your \$50.00 security deposit you will be responsible to repair the damages within 10 days of the rental date to the Board's satisfaction or MSRC will have the repairs made and billed to you.**

I certify that the above information is correct. I release Manchester Swim & Racquet Club, Inc. (MSRC) and their officers, from any liability in connection with this Rental. I also understand that in the event of an accident, the Manchester Swim & Racquet Club will not be held liable and that my individual health insurance policy will be the primary insurer. I am of the understanding that my guests and I will swim at our own risk. I have read the Policies & Procedure Manual and I am in full compliance. I understand that my reservation is complete and non-refundable upon completion of this contract.
